The Law Enforcement Council

The Law Enforcement Council (Council) is tasked with the general inspection of the effectiveness, quality and management of the judicial organizations, and the judicial cooperation between the BES islands, Sint Maarten and Curacao.



Youth (Crime) Sint Maarten

Several factors detailed in State 2024:

- Need for cooperation from a cross-ministerial and well-functioning chain approach.
- Causes and consequences of youth problems and youth crime well known and rooted in the social, economic, political and cultural domains.
- Behavior of young people and, by extension, youth crime is a shared problem and largely transcends repressive approach of judicial system.

Integrated chain approach

State 2024:

- Focuses on local circumstances, issues and their consequences for law enforcement, the entire chain and society as a whole.
- Advocates for an integrated chain approach, which goes further than just the judicial law enforcement chain and includes these four pillars and aspects.

Review MLC

Year report: 2016
Year 1st review: 2021
Recommendations: 8
Compliance: 43,7% ★

Main points:

- Rehabilitation of underage boys in the age category of 12 to 18 years does not seem top priority.
- Lack of available resources has consequences for: filling critical positions (e.g. behavioral scientist); necessary repairs; full educational program and daytime activities; increasing level of security measures.

Detention & monitoring CPT recommendations



- **Forensic care**
-Inspection initiated in 2023 and currently limited to monitoring.

- **Detention of foreigners**

Year report: 2024
Recommendations: 9

Main points:

- Treatment of foreigners in general humane
- Steering on CPT's recommendations by Ministry insufficient.
- Immigration detention center lacking in particular in aspects of security, leading to unacceptable conditions.

- **Prison and house of detention**

Continuous monitoring of prison and detention center.

General Review: 5th Sub-inspection (IBPS)



- **Admission and expulsion of foreigners**

Year report: 2014
Year 1st review: 2019
Recommendations: 6
Compliance: 33,3% ★

- **Border control on the movement of persons**

Year report: 2014
Year 1st review: 2017
Recommendations: 14
Compliance: 40.6% ★

Main points:

- Many recommendations, including important preconditions (personnel policy, organization plan/job classification system, policy and legal framework) still not addressed after almost 10 years.
- Without change, structural improvement not possible.
